 28 Temporary Letters may find it beneficial to see the Order Appointing Temporary Guardian or Order Relating to  
 Extension of Temporary Guardianship. If General Letters of Guardianship have been issued and not subsequently  
 rescinded or revoked, these Temporary Letters of Guardianship are null and void.
