

## Substance Abuse Issues

Focus for this training - Alcohol Related Issues

#### What percentage of population suffers from Alcohol Use Disorder (AUD)?

#### Over 10%

#### Between 5% and 10%

Less than 5%

#### Substance Abuse General Population

10% Alcohol/AUD

3% Drug/SUD

80% Drug Addicts also Alcoholics

75% of Addicts are employed

95,000 people die each year from alcohol related issues

## What is Alcohol Use Disorder (AUD)?

- Medical condition impaired ability to stop or control alcohol use despite adverse social, occupational, or health consequences.
- Physical Components
- Mental Health Components
- AKA = Alcoholism

## **Ethics Scenarios**

What should you do when you observe an LUI in progress?

#### Scenario 1

For over a year, you are involved in litigating a large case with opposing counsel, Joe Cuervo. During conversations with Joe, sometimes his speech seems slurred and his behavior seems off.

#### Scenario 1 Cont.

The case proceeds to trial. On the second day of trial, after returning from lunch, Joe's speech is again slurred, and his behavior has changed. He appears to have a hard time holding exhibits and is unsteady on his feet. After approaching Joe to discuss an evidentiary issue, you smell what appears to be alcohol on his breath.

## Impaired Lawyer

Ethical Rules

## Rule 1.1: Competence

A lawyer shall provide competent representation to a client. Competent representation requires the legal knowledge, skill, thoroughness and preparation reasonably necessary for the representation.

## Rule 1.3: Diligence

A lawyer shall act with reasonable diligence and promptness in representing a client.

### Rule 1.6(a): Duty to Withdraw



A lawyer shall not represent a client or, where representation has commenced, shall withdraw from the representation of a client if:



(1) The representation will result in violation of the Rules of Professional Conduct or other law;



(2) The lawyer's physical or mental condition materially impairs the lawyer's ability to represent the client

## Observing Attorney

**Ethical Obligations** 

#### Rule 8.3:

#### Duty to Report

A lawyer who **knows** another lawyer has committed a violation of the Rules of Professional Conduct that raises **a** substantial question as to that lawyer's honesty, trustworthiness or fitness as a lawyer in other respects, shall inform the appropriate professional authority.

## Key: "Knowledge"



Actual knowledge of the fact in question or knowledge may be inferred from circumstances.

#### Options On How To Handle

Request Break During Proceeding

- Talk to Lawyer if you believe you can
- Discreetly Inform Court Clerk of Issue/Request Meet with Court
- Request Continuance

Contact Nevada Lawyers Assistance Program ("NLAP")/Lawyers Concerned for Lawyers ("LCL")

Possible Reporting Obligation – Depending on Severity of the Issue

ABA Formal Opinion 03-431, August 8, 2003

#### Scenario 1 – Observing Judge

You are the presiding judge in this scenario. You noticed what appeared to be odd behavior by Joe Cuervo after the lunch break – particularly his inability to handle exhibits.

Opposing counsel, Mr. Teetotalbaum, abruptly asked for a recess – right after lunch with the jury in the box waiting to hear evidence. You reluctantly agree. Shortly thereafter, your courtroom deputy explains that Mr. Teetotalbaum is concerned that Mr. Cuervo may be under the influence.

#### What are your options?



Call your therapist **B** 

Hold a hearing outside presence of jury to discuss **C**



## Ethical Considerations – Presiding Judge

Nevada Code of Judicial Conduct Canons 2.14 & 2.15

#### Canon 2.14

"Reasonable Belief" that performance of lawyer or another judge impaired by drugs, alcohol, mental/emotional/physical condition, "shall take appropriate action"



### Comments to Canon 2.14

- Referral to Lawyer/Judicial Assistance Program
- Talk to Impaired Lawyer
- May Require Referral to Appropriate Agency (State Bar)





A judge having <u>knowledge</u> that a lawyer has committed a violation of the NRPC



Raises **<u>substantial question</u>** regarding the lawyer's ... fitness as a lawyer in other respects



shall inform the appropriate authority.

### Scenario 2

You are a fulltime District Court Judge in the 8<sup>th</sup> Judicial District Court. Your law clerk is Johnny Walker, who is under your direct and sole supervision. For the first six months or so, Johnny was a very productive and highly effective law clerk.

Recently, Johnny's behavior and worked has changed. Johnny routinely comes to work late and calls in sick – usually on Mondays. After observing Johnny, you notice his physical appearance has also changed – he is losing weight, his skin is gray/pale, his face is red, and his eyes are red and bloodshot.

# Scenerio 2: Cont.

Johnny's performance is also getting worse – his writing becomes sloppy, his draft orders fail to cite to the NRS or controlling authority. Last week, Johnny failed to attend court hearings that were necessary to assist you in drafting significant orders in both a civil and criminal case.

You suspect Johnny may be suffering from a substance abuse problem.



Supervising Judge

# Canon 2.12 – Supervision Duties

(A) A judge shall require court staff, court officials, and others subject to the judge's direction and control to act in a manner consistent with the judge's obligations under this Code.



### Canon 2.14

"Reasonable Belief" that performance of lawyer or another judge impaired by drugs, alcohol, mental/emotional/physical condition, "shall take appropriate action"

Referral to Lawyer/Judicial Assistance Program

Talk to Impaired Lawyer/Judge May Require Referral to Appropriate Agency (State Bar) Issues for Supervising Judge – Employment and Other Issues

Obligation to Adopt Measures to Prevent Violations of Rules

Can accommodations be made to allow to work on legal matters WITHOUT violating the judicial canons?

Are there instances of rule violations that have already occurred that are serious enough to cause "serious question" as to ability and require reporting?

### Issues to Consider



Report to LCL/NLAP without disclosing confidences

ABA Formal Opinion 03-429, June 11, 2003; *In re Clegg*, 41 So.3d 1141 (La. S. Ct. 2010) (good example of handling supervised attorney situation)

### Scenario 3

Rumors abound in your small legal community that Judge Amber Ale, a state trial court judge, may have a drinking problem. You are an attorney who practices in front of Judge Ale in Reno. You recently heard that Judge Ale was seen intoxicated at Louis Basque Corner in Reno where she spilled water and yelled profanities at a waiter, and shouting "do you know who I am?" When the police arrived, she called them pigs and oinked.

You were told that Judge Ale was also arrested for DUI.

You have a case pending before Judge Ale and you have hearing set before her on a motion for summary judgment about a week after you hear the above gossip.

# Scenario 3 Cont.

At your hearing, Judge Ale seems to have a difficult time walking onto the bench – appearing a bit wobbly.

The case is called and you approach the lecture to argue. However, before you can begin, Judge Ale throws a pen at her courtroom deputy to get her attention and seems to ignore you.

Undeterred, you begin your argument. After introducing yourself, Judge Ale begins to yell obscenities at you, calls you a "f\*%\$ing idiot" and tells you to sit down before she has you arrested. Her speech is clearly slurred and she seems to have a hard time sitting up. Judge Ale is clearly intoxicated.

# Drunk Judge: What do you do at the hearing?

Call her a "f\*&^ing idiot" back - then put your hands out for the cuffs

Leave

Ask for recess/continuance

Attempt to speak with Opposing Counsel

Fake a heart attack



Maybe you remember Miami-Dade County Judge Jacqueline
Schwartz from previous headlines. She's the judge who told a
Coconut Grove convenience store clerk "go fuck yourself" in a row involving an opponent's campaign sign. She also once sent out an election victory email boasting about being an "Anglo" who defeated a "nondescript Hispanic."

Well, she's back at it again. According to a report by the state's Judicial Qualifications Committee (JCQ), in March she showed up noticeably impaired in public and on the bench and has been on paid medical leave since then.

**Update:** The State Supreme Court has **ruled** that Schwartz will be suspended, but will still mull over whether the suspension should be with or without pay.

# Their Loved Ones

### Effects Of Substance Abuse on Others

2012 – 10% Children Live with an Alcoholic Parent

2007 - 76 million Adult Children of Alcoholics lived in United States (43% of Population)

Addiction of 1 Addict affects (on average) between 7 to 10 other people

Increases Risk of Domestic/Family Violence

Children of Alcoholics 4 times more likely to become addicts

# What Can You Do

For Yourself and the Addict

### Self-Care

- Take Care of Yourself
- Get Help for Yourself
- Programs (Open AA meetings, Al Anon, Therapy, etc.)

#### Understand the Three C's

- Didn't Cause
- Can't Cure
- Can't Control

### Don't Enable

- Set Boundaries
- Detach with Love

### Don't Talk To Them When Using

 Can't reason with booze/dope

### Consider Intervention

- They have to want help
- They have to be at a place to get help

#### Research

- Detox Facilities
- Treatment Facilities
- Outpatient Help/Treatment
