21 The Court finds that it has jurisdiction over the parties and this matter. Based on the  
22 filings, testimony, and any evidence presented at hearing, the Court makes the following findings  
by clear and convincing evidence:

- 23 (1) The Court has jurisdiction over the parties and this matter;  
24 (2) The adverse party poses a risk of causing personal injury to himself or herself or  
25 another person by possessing, having under his control, purchasing or otherwise  
26 acquiring any firearm; and

1 (3) The adverse party has engaged in the following high-risk behavior(s) as defined in  
2 NRS 33.550:

- 3  **Physical Force:** Used, attempted to use, or threatened physical force against  
4 another person;
- 5  **Threat of Imminent Violence:** Communicated a threat of imminent violence  
6 toward himself or herself or against another person;
- 7  **Act of Violence:** Committed an act of violence toward himself or herself or  
8 another person;
- 9  **Pattern of Violence:** Engaged in a pattern of threats of violence or acts of  
10 violence against himself or herself or another person, including, without  
11 limitation, threats of violence or acts of violence that have caused another  
12 person to be in reasonable fear of physical harm to himself or herself;
- 13  **Imminent Threat to the Safety of the Public:** Exhibited conduct which a  
14 law enforcement officer reasonably determined would present a serious and  
15 imminent threat to the safety of the public;
- 16  **Firearms Danger:** Engaged in conduct which presents a danger to himself or  
17 herself or another person while:
  - 18  In possession, custody, or control of a firearm; or
  - 19  Purchasing or otherwise acquiring a firearm;
- 20  **Convictions:** Has been convicted of:
  - 21  Violating a temporary or extended order for protection against  
22 domestic violence issued pursuant to NRS 33.020;
  - 23  Violating a temporary or extended order for protection against  
24 sexual assault issued pursuant to NRS 200.378; or
  - 25  Administering a controlled substance to another without their  
26 knowledge and with the intent to commit a crime of violence  
27 against that person or that person's property pursuant to NRS  
28 200.408;
- Controlled Substances or Alcohol:** Abuse a controlled substance or alcohol  
while engaging in high-risk behavior;
- Firearm Acquisition:** Acquire a firearm or other deadly weapon within the  
immediately preceding 6 months before engaging in high-risk behavior; and

(4) Less restrictive options have been exhausted or are not effective.

1 Good cause appearing, **IT IS HEREBY ORDERED:**

- 2 1. **THE ADVERSE PARTY IS REQUIRED** to immediately surrender any firearm in your  
3 possession or under your control by surrendering your firearm(s) to:

- 8 2. Within 72 hours of surrender or one business day, whichever is later, **THE ADVERSE**  
9 **PARTY IS REQUIRED** to:

10  provide the Court with the original receipt issued by law enforcement that  
11 includes a description of all firearms surrendered; or

12  provide the Court and \_\_\_\_\_

14 with the name and address of the person designated in the order and a written  
15 description of each firearm surrendered.

- 16 3. **THE ADVERSE PARTY IS PROHIBITED** from possessing or having under your  
17 control any firearm while this order is in effect.

- 18 4. **THE ADVERSE PARTY IS REQUIRED** to surrender any permit authorizing you to  
19 carry a concealed firearm as permitted under NRS 202.3657.

21 **IT IS FURTHER ORDERED** that the \_\_\_\_\_ shall

5 **ORDER TO LAW ENFORCEMENT**

6 1. Whether or not a violation of this Extended Order occurs in the presence of a law  
7 enforcement officer, the officer shall arrest and take into custody the Adverse Party:

8 (a) With a warrant; or

9 (b) Without a warrant if the officer has probable cause to believe that:

10 (1) An Extended Order for Protection Against High-Risk Behavior has been  
11 issued against the Adverse Party;

12 (2) The Adverse Party has been served with a copy of this Order; and

13 (3) The Adverse Party has violated this Order.

14 2. If such law enforcement officer cannot verify that the Adverse Party was served  
15 with a copy of the Application for and Declaration in Support of a High-Risk Protection Order  
16 and this Order, the officer shall inform the Adverse Party of the following:

17 (a) the specific terms and conditions of this Order;

18 (b) that the Adverse Party now has notice of the provisions of this Order;

19 (c) that a violation of this Order will result in the Adverse Party's arrest;

20 (d) the location of the Court that issued the original Order and the hours during  
21 which the Adverse Party can obtain a copy of this Order; and

22 3. Information concerning the terms and conditions of the Ex Parte Order for  
23 Protection Against High-Risk Behavior, the date and time of any notice provided to the adverse  
24 party and the name and identifying number of the law enforcement officer who gave the notice  
25 must be provided in writing to the applicant and noted in the records of the law enforcement  
26 agency and filed with the court.
