# **WELCOME**

Dear Judges, Juvenile Hearing Masters and Attorneys:

In my State of the Judiciary speech given to the Nevada Legislature in March, 2007, I reported that child abuse and neglect issues were one of the Court's highest priorities for the coming year.

At the Judges and Family Law Conference in Ely this year, outreach was made to raise the level of awareness and importance among judges and attorneys who are involved in these very complex cases. Additionally, attorneys were asked to help at-risk children and families in the form of pro bono representation. Many of you are among those attorneys who answered the request for assistance.

I am pleased to inform you that, as promised, a training session on child abuse and neglect matters has been scheduled for **December 6 & 7, 2007** at the Embassy Suites Hotel-Convention Center in Las Vegas.

This will be an interactive training of Judges and Juvenile Hearing Masters who hear or are interested in hearing child welfare matters. In addition to judicial officers, this training is targeted to attorneys, including District Attorneys, Attorneys General, and Public and Private Attorneys for Children and Parents. Attorneys who are currently handling these cases or have taken a case pro bono during the past 24 months, or those who would be willing to take a case pro bono, will be given preference. Twelve hours of CLE credit will be offered, including 1.5 ethics credits.

On behalf of the Court Improvement Project, Justice Saitta and I extend this personal invitation to you and hope you will give strong consideration to attending this important and very worthwhile training opportunity.

## **TRANSPORTATION**

**PERSONAL VEHICLE:** Mileage for personal transportation is reimbursed at \$.485 per mile, but in the case of long-distance solo driving for personal convenience when a less expensive mode of transportation is available, the reimbursement rate is \$.2425 per mile.

**AIRPORT PARKING:** If you leave your personal vehicle at the Reno airport, parking receipts **MUST** be provided with your Claim for Travel Expense form in order to be reimbursed. Please use long-term parking whenever possible. Parking will be reimbursed to a maximum of \$12.00/day.

AIR TRAVEL: Airfare on Southwest Airlines to Las Vegas, Nevada may be charged directly to AOC through Classic Travel in Carson City (775-883-9331) or The Travel Center in Reno (775-323-0110). If charging your airline ticket directly to AOC, use budget account number 1484-12. Participants are encouraged to purchase the fully refundable airline ticket. Spouse and guest tickets may not be charged to AOC. Lower fares may be available with cancellation penalties; however, please note, cancellation penalties are not reimbursable by AOC. The passenger coupon of your airline ticket or, if flying ticketless, the ticketless itinerary of your airline ticket MUST accompany your Claim for Travel Expense.

**GROUND TRANSPORTATION:** Only taxi and shuttle expenses between the Las Vegas Airport and the Embassy Suites Hotel-Convention Center will qualify for reimbursement. Receipts for such travel must be submitted with your Claim for Travel Expense following the Conference.

### HOTEL INFORMATION

**ROOM RESERVATIONS:** Reservations can be made by calling the Embassy Suites Hotel-Convention Center at (702) 893-8000 or (888) 243-9146. **Reservations must be made by Friday, November 15, 2007.** When making reservations, reference Embassy Suites-Convention Center and group code "CIP-Court Improvement Project."
