





Judge Carla Baldwin is currently a United States Magistrate Judge in Reno, where she presides over a variety of criminal and civil matters. Prior to her elevation to the bench, Judge Baldwin gained extensive and varied trial experience in both federal criminal and complex civil law. From 2010 until her appointment to the bench, Judge Baldwin served as an Assistant United States Attorney in the criminal division of the United States Attorney's Office in Nevada. During her tenure as an AUSA, Judge Baldwin specialized in prosecuting crimes against children, human trafficking, complex white-collar cases, immigration, election crimes and public corruption. Judge Baldwin tried numerous jury and bench trials and argued several cases before the Ninth Circuit Court of Appeals. As an AUSA, Judge Baldwin served as the District of Nevada's coordinator for the Project Safe Childhood initiative, the coordinator for the Northern Nevada Financial Crimes Task Force, the District of Nevada's Professional Responsibility Officer, and the District's Elections Officer. Prior to becoming a federal prosecutor, Judge Baldwin was an associate attorney with the law firm of McDonald Carano Wilson LLP from 2005 until 2010. While at the firm, Judge Baldwin's practice focused primarily in the areas of appellate law and complex commercial and civil litigation. As an associate, Judge Baldwin tried a four-month long complex civil jury trial and argued numerous cases before the Ninth Circuit Court of Appeals, the Nevada Supreme Court, and various state and federal courts in Las Vegas and Reno. Prior to her time at MCW, Judge Baldwin served as a judicial law clerk to the Honorable Procter R. Hug, Jr. on the Ninth Circuit Court of Appeals and the Honorable Peter I. Breen on the Second Judicial District Court for Washoe County, Nevada. Judge Baldwin has been active in various legal organizations and pro bono projects. Currently, she is a Master Emeritus of the Bruce R. Thompson Inns of Court in Reno, a volunteer for the We the People Program, and a member of Federal Magistrate Judge's Association. Previously, Judge Baldwin served on the Board of Directors for Step 2, Inc., a drug and alcohol recovery center in Reno, an ASECNT mentor for Hug High School, and was an active member of the Ninth Circuit's Pro Bono program.

Chief Judge Linda Marie Bell was elected to the Eighth Judicial District Court of Clark County in 2008. She hears primarily civil matters as well as presiding over the Veterans Treatment Court and OPEN Specialty Court programs. Prior to taking the bench, she spent seven years in the non-capital post-conviction unit of the Federal Public Defender handling complex post-conviction cases. Judge Bell has argued eleven cases before the Ninth Circuit Court of Appeals, including the published case of Chambers v. McDaniel. Judge Bell served as a public defender for twelve years and spent five years as a Clark County Public Defender. In 1993, Judge Bell received her law degree magna cum laude from the University of San Diego School of Law. She was as an Articles Editor for the USD Law Review. She received moot court awards for writing and oral advocacy. During law school, Judge Bell worked for the Clark County District Attorney's Office and the San Diego Public Defender's Office. A life-long Nevada resident, Judge Bell graduated with honors from the University of Nevada, Reno, in psychology. Judge Bell is an officer on the board of the ABA National Conference of State Trial Judges. She is a past president of the Nevada District Judges Association, and the Howard D. McKibben Chapter of the American Inn of Court. Since 2011, Judge Bell has taught criminal law and criminal procedure at the University of Nevada Las Vegas. She was honored as the Trial by Peers Judge of the Year in 2011. Among other professional and community activity, Judge Bell has served as a member of the Court Records Subcommittee, Court Appointed Special Advocates (CASA), as well as on various civic boards.



Kevin J. Bowling JD, MSJA, CCE, retired from the judicial branch of government following a 44-year career as an attorney, court administrator, judicial branch educator, and consultant. Most recently, Mr. Bowling served as the Trial Court Administrator and Attorney Referee for the 20<sup>th</sup> Judicial Circuit Court and the Ottawa County Probate Court in Ottawa County, Michigan. He is a Past President of the National Association for Court Management, Co-Chair of the COSCA/NACM Joint Technology Committee, and Chair of the DOJ Global Advisory Committee. His work in the judicial system includes judicial branch training in numerous U.S. states and service in western Africa as Deputy Chief of Party for the Nigeria Justice Sector Assistance Project. Mr. Bowling served for 20 years in a variety of positions with the Michigan Supreme Court, including State Judicial Educator and Regional Court Administrator. Mr. Bowling received his BA in Political Science/Public Administration from Providence College, Providence, Rhode Island: a MS in Judicial Administration from the University of Denver College of Law; a JD from Thomas M. Cooley Law School in Lansing, Michigan, and is a Fellow of the Institute for Court Management. He is a member of the State Bar of Michigan, Ottawa County Bar Association, National Association for Court Management, and Michigan Juvenile Justice Vision 20/20. Mr. Bowling has served on the Board of Directors of the National Association for Court Management, the National Association of State Judicial Educators, and is a faculty member of the National Judicial College. Mr. Bowling is a trained mediator and served for 19 years on the Board of Directors for Mediation Services in Holland, Michigan.

Dean Erwin Chemerinsky became the 13th Dean of Berkeley Law on July 1, 2017. Prior to assuming this position, he was the founding Dean and Distinguished Professor of Law, at University of California, Irvine, with a joint appointment in Political Science. Before that he was the Professor of Law and Political Science at Duke University for four years, and from 1983-2004 was a professor at the University of Southern California Law School. He also has taught at DePaul College of Law and UCLA Law School. He teaches Constitutional Law, First Amendment Law, Federal Courts, Criminal Procedure, and Appellate Litigation. He is the author of 10 books and more than 200 law review articles. He writes a weekly column for the Sacramento Bee, monthly columns for the ABA Journal and the Daily Journal, and frequent op-eds in newspapers across the country. He frequently argues appellate cases, including in the United States Supreme Court. In 2016, he was named a fellow of the American Academy of Arts and Sciences. In January 2017, National Jurist magazine again named Dean Chemerinsky as the most influential person in legal education in the United States.

Chief Judge Michael P. Gibbons was selected as a judge of the inaugural Nevada Court of Appeals by Governor Brian Sandoval in December 2014. He served as the first Chief Judge for the court from 2015-2017 and was appointed Chief Judge twice more by the Nevada Supreme Court and continues to serve in that capacity. Chief Judge Gibbons had served as a District Judge for twenty years at the time of his appointment to the Court of Appeals. He was elected to the Ninth Judicial District Court in Minden in 1994 and was reelected four consecutive times. He presided over every type of district court case including criminal, civil, guardianship, probate and trusts, juvenile and family matters. While serving as a district judge, the Nevada Supreme Court appointed Judge Gibbons to hear cases in districts throughout the state including ten appointments to Clark County. Consequently, Judge Gibbons has presided over jury trials in four different judicial districts in Nevada including in the First, Fifth, Eighth and Ninth districts. Chief Judge Gibbons has a lengthy record of service to the bench and bar having served as President of the Nevada District Judges' Association in 2004 and 2005; serving eight years on the Nevada Committee on Judicial Ethics and Election Practices; and six years on the board of trustees of the National Council of Juvenile and Family Court Judges. Since joining the Court of Appeals, he served on the Nevada Supreme Court's Guardianship Commission helping to create the Bill of Rights for persons subject to a guardianship. He has been a certified soccer referee for over twenty years and continues in that capacity in high school, adult and youth leagues including in the 2021 State 5A Girls' championship match.



During her time as a defense attorney and a prosecutor, Judge Jones appeared in court almost every day. 

# CLAIM FOR TRAVEL EXPENSE INFORMATION

# **Claim for Travel Expense**

The Supreme Court of Nevada, AOC Accounting Unit will, upon receipt, process your Claim for Travel Expense form for reimbursement. If the original Claim for Travel Expense form is complete, accurate, and includes the required receipts, you should receive your reimbursement within 7 business days. The Travel Claim will ONLY be accepted in electronic format at the request of the AOC Accounting Unit. We will be unable to accept paper travel claims on site. Please refer to the travel claim procedures and documentation requirements as outlined on the event website. If you have any questions prior to submitting your claim for Travel Expense, please contact the AOC Accounting Unit at judicialbranchtravel@nvcourts.nv.gov.

*Note:* When in doubt as to whether a cost incurred during travel status can be reimbursed, keep an itemized receipt, claim the cost on the Claim for Travel Expense form, and submit the receipt with the claim. The AOC Accounting Unit will notify you if the expense claimed is allowable for reimbursement under the <u>Nevada Supreme Court Travel Policy</u>.

# Notes Regarding Travel Reimbursement & Eligibility

**Attendance:** The total Summit possible hours are 17.5. Failure to attend a minimum of 75% may result in less than full reimbursement. A brief memo of explanation for partial attendance will help to facilitate your travel claim.

**Lodging:** Only the group rate plus tax and resort fee are reimbursable. The group rate is \$96.00 plus 13% room tax, plus \$5.00 county tax, totaling \$113.48 per night. There is an optional resort fee upon check-in of \$20 per night which is also reimbursable. If you do not intend to use in-room internet or the fitness facilities, then you are encouraged to forego the resort fee. Expenses incurred for phone-in reservations and/or early check-in are not reimbursable. Submission of the original hotel receipt must accompany your Claim for Travel Expense form.

**Meals:** Meals provided include: breakfasts on May 4, 5, and 6; lunch on May 5, and the banquet dinner on May 5. Meals not provided will be reimbursed as outlined in the <u>Nevada Supreme Court Travel Policy</u>. The Supreme Court's per diem rates (no receipt required) are \$13.00/breakfast, \$15.00/lunch, and \$26.00/dinner for meals not provided from breakfast on Monday, May 2, through dinner on Friday, May 6.

Air Travel: Please include the original receipt with your Claim for Travel Expense form to receive reimbursement. Boarding passes will not be accepted as documentation for reimbursement.

**Airport Parking:** Original receipts for personal vehicle parking at the airport must be provided with your Claim for Travel Expense form in order to be reimbursed.

Airport Shuttle: Original receipts must be provided with your Claim for Travel Expense form in order to be reimbursed.

**Personal Vehicle:** Personal vehicle mileage is reimbursed at \$0.585 per mile, round-trip, for your travel. However, if a less expensive method of travel is available and you are driving for your personal convenience, you will only be reimbursed at the personal convenience mileage rate of \$0.2925 per mile, round-trip. Mileage reimbursement is from the official work station or home, whichever is less. Use the official State of Nevada Road Map mileage chart or Google Maps for mileage estimation.

(CONTINUED)

## Notes Regarding Travel Reimbursement & Eligibility (continued)

**Rental Cars:** The State has negotiated contracts with Hertz Corporation and Enterprise Rent-A-Car with assurances for: reasonable rates, first-dollar liability insurance without cost, and a full physical damage waiver with no deductible. Should a judge decide to rent a car from any company other than those with whom the State has contracts, the AOC will not provide reimbursement for insurance or sales tax. Keep in mind, the judge and/or the judge's court, and not the AOC, will be at risk for collision claims and comprehensive losses (including theft) if a vehicle is rented from a company other than the contracted companies listed below. The fuel purchase option is not reimbursable. Travelers must refuel the rental car before returning, to avoid penalty refueling costs. Remember, the receipt for fuel purchase is required for reimbursement. Extra rental accessory options such as roadside assistance, satellite radios, GPS, etc., are also not reimbursable expenses.

**Incidental Expenses:** The AOC will reimburse you for incidental expenses at \$5.00 per day while in travel status. Incidental expenses are costs incurred for fees relating to luggage carts, metered parking, toll charges, and tips. Receipts are not required.
