### 1. United States v. Brandonn Pruitt, 2:16-cr-285-APG-NJK

# (C) Importance and Impact:

Pruitt persuaded and recruited a 14-year-old girl to prostitute for him. For three years, Pruitt convinced the girl to stay with him and arranged her travel from California to Las Vegas to engage in commercial sex acts. He acted as the victim's pimp, took photos of her that were posted online for prostitution "dates," and booked hotel rooms for the "dates." Pruitt used violent force and the victim's romantic feelings for him to coerce and entice her compliance. After he was arrested, Pruitt tampered with the victim and attempted to prevent her from cooperating with law enforcement in prosecuting the federal criminal charges. Pruitt also unlawfully possessed two stolen guns.

Before trial, Pruitt sought to suppress his pre-*Miranda* statements and items seized from an apartment (including a firearm, drugs, and a journal). The first trial resulted in convictions for felon in possession of a firearm and witness tampering, with a hung jury verdict on two other counts. One month later, the second trial resulted in guilty verdicts on the sex trafficking and transportation for prostitution counts. The Ninth Circuit affirmed the conviction and ordered a limited remand for consideration of a minor sentencing matter. *See United States v. Pruitt*, 839 F. App'x

90, 95 (9th Cir. 2020)

This case is significant because the litigation was extensive and required creative problem solving, including a material witness warrant to ensure the victim was available to testify at trial.

#### (D) Role:

I led the federal investigation into the sex trafficking charges as well as the subsequent witness tampering investigation. I presented the case to the Grand Jury and first-chaired the suppression evidentiary hearing and both trials.

#### (C) Importance and Impact:

A concerned citizen gave Las Vegas Metropolitan Police Department responding officers an SD card belonging to Ditirro that contained child sexual abuse images and videos, including images depicting infants, toddlers, sadomasochism, and violence. The SD card also contained child sexual abuse images of over 50 girls that Ditirro produced. Ditirro fiercely litigated the underlying case moving through several attorneys. He sought to suppress all evidence obtained as a result of a search warrant and his post-*Miranda* statements.

This case was significant because I had to work with several victims who were initially not comfortable testifying, including several girls who Ditirro severely traumatized when he raped them, and two others who were uncooperative due to parental pressure. Upon working with the girls and gaining their trust, I was able to obtain the needed testimony. Also, I sought justice for 45 unidentified victims of Ditirro's crimes. This case remains personally impactful to me because Ditirro's victims still reach out to me to update me on their ongoing therapy and life events.

#### (D) **Role**:

I led the federal child exploitation investigation, as well as continued investigation to identify almost 50 child victims. I continue to be involved in the investigation due to Ditirro's

custodial misconduct and sextortion of adult victims from prison. I presented the case to the Grand Jury, drafted all written briefing, including opposing multiple motions to suppress, tried the case as lead counsel, and litigated the subsequent appeal in which the Ninth Circuit affirmed the conviction and sentence. *See United States v. Ditirro*, 835 F. App'x 280 (9th Cir. 2021).

#### (C) Importance and Impact:

Fuechtener shared numerous child sexual abuse files on a peer-to-peer file sharing program. Law enforcement found over 9,000 images and videos on nine devices collected from Fuechtener's home depicting children engaging in sexually explicit conduct. Fuechtener distributed child pornography to other pedophiles in exchange for watching a father sexually assault his daughter, and was coordinating to drug and sexually molest a young boy.

After pleading guilty on the fourth day of a bench-trial pursuant to a plea agreement, Fuechtener sought to withdraw his guilty plea. I opposed the motion in writing and litigated a five-day evidentiary hearing. The hearing included five prior defense attorneys as witnesses, as well as a pre-trial detainee.

This case was significant based on intense media interest because Fuechtener was the headlining magician at the Tropicana Hotel and Casino at the time of his indictment. Additionally, it was impactful because it required coordinating with more than 10 defense attorneys who Fuechtener retained, fired, and accused of ineffectiveness over the course of the years-long litigation. Finally, it continues to resonate with me because I litigated a motion to restrain funds while on maternity leave when Fuechtener was attempting to transfer funds to a co-conspirator to avoid paying restitution to the victims. This litigation created favorable precedent in an emerging civil/criminal issue. I was able to secure almost one million dollars for restitution and fines, which went directly to victims and victim services.

(D) Role:

I was lead counsel during the trial. I negotiated the plea agreement. I litigated a five-day evidentiary hearing. I defended the conviction and sentence on direct appeal. *See United States v. Fuechtener*, No. 19-10097, 2020 WL 6707338, at \*1 (9th Cir. Mar. 9, 2020), *reconsideration denied* (May 15, 2020), *cert. denied*, 141 S. Ct. 852, 208 L. Ed. 2d 425 (2020).

#### (C) Importance and Impact:

Justin Anthony Fisher and Joshua Ray Fisher, identical twins, sexually exploited dozens of girls they met on a cell-phonebased messaging service. Justin Fisher sexually exploited a 14year-old girl and a 15-year-old girl. He lied to the underage victims about his age, convinced them that they were in a romantic relationship, and directed the victims to take nude photos of themselves to send to him. Justin had sex with the victims and produced pornographic images of their sexual encounters. Later, he conspired to and attempted to stop one of his victims from cooperating with law enforcement. Justin shared the sexually explicit images of both underage victims with his twin and others over the internet.

Joshua Fisher sexually exploited a 14-year-old girl. The abuse began when the victim was 11 years old. Joshua instructed her how to pose during live chats so that he could take screenshots of her engaging in sexually explicit conduct. Joshua shared these images with his twin. Joshua directed the underage victim to destroy evidence implicating him. Further, while in custody pending trial, the twins conspired to have their older brother destroy evidence. A concerned citizen's call allowed law

enforcement to retrieve electronic devices, which revealed at least 50 additional unidentified victims.

The Fishers filed numerous suppression motions, one which led to an evidentiary hearing involving experts and in which the government prevailed. Notwithstanding the favorable outcome, I negotiated the case pretrial to protect the child victims from needing to testify about their abuse in front of strangers.

This case was significant because I represented several girls, including a girl with developmental delays, an uncooperative victim, and a victim whose parents were both heavily involved with the case. It was impactful because I convinced the district judge to treat the Fishers' wives and children as victims giving them a voice at sentencing under the Crime Victim Rights Act. This created favorable precedent in the district.

### (D) Role:

I led the federal child exploitation investigation, as well as the continued investigation to identify almost 50 child victims. I led the witness tampering investigation, cross-coordinating with multiple jurisdictions. I presented the case to the Grand Jury, produced all written briefing in the case, including opposing multiple motions to suppress, and am assigned to litigate the appeal.

### (C) Importance and Impact:

This was a child exploitation enterprise multi-defendant case. William Thompson took sexually explicit photos and videos of a 10-year-old boy under the ruse that Thompson was a professional photographer and wanted to assist the boy in getting sponsored as a professional skateboarder. After he was released on house arrest, Thompson absconded. While on the lam, Thompson contacted at least six boys at a California Skate Park and told the boys he was a "scooter sponsor." He and his co-conspirators provided the boys with gifts to induce their compliance and to recruit other minors to be part of the "team" that he claimed he wanted to sponsor. In reality, Thompson and others recruited the "team" with the intention to produce child pornography and to sexually abuse the boys. Over a six-month period, Thompson produced over 20,000 images and videos depicting sexually explicit content of the children. These images make up at least two of the most widely shared series of child pornography images on Earth. Thompson and a co-conspirator created multiple websites to distribute the child pornography he created. When Thompson was arrested during a traffic stop in Arizona, law enforcement found over one million images of child sexual exploitation on his digital devices.

This case is significant because when I joined the USAO, the case had been indicted but plea negotiations had broken down with multiple prosecutors. After meeting with the victims and their attorneys, I was able to negotiate plea agreements with the two appearing defendants, while cross-coordinating with two different jurisdictions regarding other defendants, which resulted in substantial sentences and spared the child victims from needing to testify about their sexual exploitation.

I was co-lead counsel on this case. I negotiated the case and appeared at sentencing.

I mediated neighbor disputes ranging from barking dogs to where dumpsters were located. I also mediated several contract disputes allowing the participants to avoid civil litigation.

Perseverance, loyalty, and fairness. I believe these character traits—and my life experiences that have instilled them—qualify me uniquely to serve as a district court judge. *Perseverance* describes the drive and relentless hustle immigrants must demonstrate when leaving everything they know and love to start over in another country. I am an immigrant who came to Las Vegas when I was only one year old. In Iran, my parents were forced to choose between their lives and their faith. They left everything behind to escape persecution by the Islamic regime. They fled to Pakistan, where I was born and where we lived briefly before settling permanently in Las Vegas. This displacement and the resulting challenges we faced as new immigrants required perseverance. These experiences have shaped who I am. Rather than allowing these experiences to burden me, I have applied the perseverance I learned from my parents to succeed. Understanding the plight of refugees also has given me a unique perspective on the struggles that many marginalized groups in our community face based on who they are or where they come from.

These experiences have motivated me to remain involved in the local community, including through the Interfaith Council and with Kiwanis. My community involvement will make me a better judge because it has given me perspective on different aspects of the community and a connection with people who I would serve. In particular, my service at yearly Interfaith Forums has allowed me to meet people from different backgrounds and perspectives. The relationships built through mutual understanding and respect have been instrumental in giving me a broad view of the real-life experiences people face.

*Loyalty* has further shaped who I am. With respect to this community and its judiciary, I believe this trait makes me well suited to serve on the district court. I grew up in Las Vegas, attending elementary, middle, and high school, college, and law school here. Nevada is my

I may have been born in another country, but I have never called anywhere else home. This life experience has given me deep ties to Nevada and made me personally invested in the success of the state, its legal community, and the judiciary. When I graduated from the William S. Boyd School of Law, I felt compelled to give back to the community that helped me build such a strong educational foundation. I did so by teaching at the law school, training fierce and compassionate legal advocates who have gone on to serve the community as professors, prosecutors, defense attorneys, and public servants.

When an opportunity arose to work for the judiciary, I accepted. This was a dream come true because, ever since externing for Judge Philip Pro during law school, I knew that I could best serve the community by one day gaining enough experience to join the bench. As a judicial law clerk, first to U.S. District Judge Roger Hunt and then to U.S. Court of Appeals Judge Johnnie Rawlinson, I became intimately familiar with all aspects of case management and civil and criminal processes. My clerkship experience was particularly broad because it encompassed legal research and writing on various state, federal, and administrative law issues covering both criminal and civil matters. Through this work, I developed lifelong relationships with judges who continue to be my mentors and role-models. These experiences cemented my loyalty to both the judiciary and the judicial process as an important bedrock of a fair and just society.

*Fairness* is often closely aligned with the judiciary, and I might have discussed this trait in connection with my clerkship experiences. But I closely associate fairness with my ability to serve the community as an Assistant United States Attorney (AUSA) and will discuss it in connection with my current role. I have served as an AUSA for over five years, during which time I have gained significant litigation and case management experience investigating and prosecuting a variety of child exploitation and other violent crime matters. Additionally, I now focus on appeals, broadening my experience base further. As an AUSA, I have collaborated

Eighth Judicial District, Dept. 11 Attachment B - Q.47 Roohani, Elham extensively with state, local, and other federal law enforcement partners, the district attorney's office, and the state and federal public defender's offices to protect the community, advocate for victims, and resolve countless cases. Throughout this process, my principles of fairness and justice guide me always. Indeed, even when I have no legal or ethical obligation to disclose certain evidence, I have chosen to do so because the truth is no enemy of justice and fairness.

Notably, some of the most personally and professionally challenging cases I have prosecuted involved child sexual exploitation. I have routinely demonstrated extreme patience, stamina, empathy, and personal strength while walking a child through the most traumatic experience of their life, both as an advocate and confidante. But, despite fighting vigorously for victims, I have never allowed myself to forget the humanity of the defendant, a statement with which I believe the defense bar would agree. I believe that justice can be served only by applying even-handed and fair treatment to each person (defendant or attorney), and that consequences must be balanced with mercy. I believe it is because of my reputation to be fair, balanced, and empathetic, that I have earned the respect of my colleagues in the office and across the aisle, as well as from the bench. These traits likewise make me well suited to serve on the district court.

In conclusion, I firmly believe that people are not disposable, no matter the circumstances. My ability to focus on that truth, rather than the perceived glory of a particular position or professional success, has enabled me to meet people where they are and see them for who they can be. I believe these experiences demonstrate my commitment to the fair administration of justice, confirming that I would make an excellent district court judge. Thank you for your consideration.
