- I. Call to Order
 - Chief Justice Stiglich called the meeting to order at 2:02 p.m.
 - Ms. Harper called roll; a quorum was present.
- II. Review and Approval of Previous Meeting Summary
 - The meeting summary from May 12, 2023, was unanimously approved.
- III. Business and Action Items
 - Specialty Court Funding & Policy Guidelines Handbook Update*
 - Ms. Gouveia updated the Council on the changes made to the Specialty Court Funding Guidelines and Criteria Handbook. She explained that there were three updates with the consolidation of funding and now a single application process.
 - Funding caps were doubled to ensure funding would be consistent with previous years.
 - The reference to NRS 176.059 was removed from the handbook, as it is no longer pertinent with the passage of SB448.
 - The handbook was updated to reflect a new accounting policy regarding unspent funding and carry-forward balances.
 - The Council was asked to approve the changes made to the Specialty Court Funding Guidelines and Criteria Handbook.
 - Judge Montero made a motion to approve; Judge Dobrescu seconded the motion. The updates were approved unanimously.
 - Ad Hoc Subcommittee to Review the 2019 NCJFCJ Family Court Study

- Mr. McCormick informed the council of an assessment of Nevada's family courts completed by the National Council of Juvenile and Family Court Judges (NCJFCJ) in 2019, which included recommendations.
- Mr. McCormick explained that the intent is to create an Ad Hoc subcommittee to review and prioritize the report's recommendations, conduct a survey of judicial officers and court staff on their current business process needs, and develop/implement a plan to improve the delivery of family court services in Nevada.
- The Ad Hoc Subcommittee would have the ability to establish workgroups. Membership will be appointed by the Chief Justice as provided in the bylaws and will receive support from the AOC and the National Center for State Courts (NCSC).
- The initial iteration will be comprised of judges and administrators who deal with family law cases with the goal of having a report produced for the full council, advising on how to approach the recommendations in the NCJFCJ assessment. The subcommittee's work will accompany the Family Court Triage tool we are creating.
 - Judge Throne expressed concern over the assessment being completed in 2019 and asked if the data may be out of date.
 - Mr. McCormick acknowledged the concern and believed there is an intent to conduct another survey of judicial officers and court administrators on the matter. He added that a benefit of creating the subcommittee is that it could re-examine the report to determine if it is still informative and if another course of action would need to be considered.
- Ms. Lerud asked if the Ad Hoc Subcommittee would be considering the possibility of resources being dispersed statewide in the context of family court services rather than in the urban areas exclusively.
 - Mr. McCormick stated that the intent is to include rural jurisdictions. He added that he believes a holistic approach is important.
 - Chief Justice Stiglich asked if a membership list has been created.
 - Mr. McCormick will forward the list to the Chair.
- Chief Judge Wiese expressed concern over a potential conflict the Eighth Judicial District Court may have as they have positioned themselves to pursue new legislation using the NCJFCJ assessment.
- Judicial Perspectives on Civility

- Judge Toone provided the council with an overview of the judicial perspectives on civility, stating that the Nevada State Bar has highlighted the need for improvement in this area and recently adopted a creed of professionalism and civility.
- He added that his intention in recommending this as an agenda item is that it may lead to additional discussion with judges.
- He shared that it may be tempting to get frustrated when attorneys and litigants become uncivil but has found in studying the issue, there are things one can do to better model civility.
- He referred the council to the materials attached to the agenda to help better understand and anticipate stressors that lead to incivility. He recommended the council take this topic and materials back to their regions for discussion and training.
 - Chief Justice Stiglich thanked Judge Toone and acclaimed the materials on page 24 as being a good addition to a bench book.
- First Amendment Auditors
 - Chief Judge Wiese reported that the individual who prompted the discussion around First Amendment Auditors in the 8th Jurisdiction is in custody for another matter and is no longer causing issues.
 - He added that they prepared an Administrative Order that addresses First Amendment rights and recording in a courthouse. The order has been implemented in Clark County and signs have been posted in the building.
 - Judge Sturman shared a company called "Yondr" that is popular with performers. The company provides guests with cases that remain locked during an event, preventing them from accessing

the phone until the conclusion of the event when the case would be unlocked. She presented this as an option for courts dealing with First Amendment Auditors. Please contact her directly for additional information.

- Ms. Lerud informed the council that the Second Judicial District has a similar system in place for use during specific trials, such as when there are safety concerns for witnesses and jurors. She was confident the system is from Yondr. Please contact her directly for additional information.
- Chief Judge Wiese pointed out that this solution may be better tailored for specific trials as
 opposed to use throughout the whole courthouse.
- IV. Standing Committee Reports
 - Court Administration Committee
 - Mr. McCormick reported that the committee welcomed new court administrators. The Committee has been discussing ADA issues and accommodations. They are working on a draft ADA "cheat sheet" that is being vetted through the committee.
 - Court Improvement Program
 - Mr. McCormick reported that <u>AB148</u> passed without the language change on the term "master" to "magistrate." Going forward they would like to find a word that meets everyone's needs and remove the term "master" from statute.
 - The program is embarking on the Judicial Court and Attorney Measures of Performance data project.
 - The program is continuing to work on spreading the message regarding the Juvenile Dependency Mediation program.
 - They are increasing the amount of collaboration work they are conducting with Nevada tribes.
 - The Community Improvement Council summit will be held in September.
 - The Judicial Roundtable will be held on September 27th. The full summit will be held on September 28th and 29th at the Atlantis in Reno.
 - Specialty Court Funding Committee
 - Ms. Gouveia reported that the committee reviewed and approved their final budget allocations for the fiscal year 2024. Specialty Court Funding payments have been dispersed. Please contact Ms. Gouveia directly if payment has not been received.
 - The committee hosted its first Nevada Treatment Court Workers Social Hour. At this event, all people involved in specialty courts in Nevada were invited to network and interact. They hope to continue this event in the years to come.
 - She reported that the National Association of Drug Court Professionals will be known as "All Rise" moving forward.
 - The Las Vegas Justice Court began a new mental health specialty court, presided over by Judge Nadia Wood who assisted with <u>AB405</u> in providing statutory authority for limited jurisdiction courts to establish a mental health court.
 - The committee completed a full peer review process in the Sixth and Seventh Judicial Districts and are working on setting up the next round of peer reviews.
 - The Nevada Specialty Courts Conference will be held from October 16th to 18th, 2024 in Reno.
 - Chief Justice Stiglich asked if there are changes in enrollment numbers in specialty courts and if there are still those who hesitate to refer people to specialty courts.
 - Ms. Gouveia replied that there has been a sharp decline in participants but buy-in among judges is improving. She offered to share a full peer review report during the next JCSN meeting which will be useful in encouraging buy-in from those who are not familiar with specialty courts.
- V. Report of Regional Council Meetings
 - Clark Regional Judicial Council

- Chief Judge Weise stated the Council discussed First Amendment Auditor policies, legislative updates, and AOC updates.
- He informed the council that their Court Appointed Special Advocates (CASA) program is quickly growing and that they will be using CASA funds to broadcast a commercial during the Super Bowl this year which is expected to reach a million residents of Clark County. They are hoping to recruit more CASA volunteers.
- North Central Judicial Council
 - Judge Soderquist stated that they also discussed First Amendment Auditors. He thanked Chief Judge Wiese for the Administrative Order. They are tailoring it for use in the Fourth Judicial District.
- South Central Regional Judicial Council
 - Judge Dobrescu reported that the meeting primarily focused on updates. Please refer to the meeting materials for more information.
- Washoe Regional Judicial Council
 - Ms. Lerud reported that they did not hold a meeting but took the opportunity to notify the council that Washoe County Courts have seen an increase in activity in criminal cases. She added that the Reno Justice Court changed some of their scheduling orders to move cases faster.
 - Chief Justice Stiglich asked if there was an increase in cases, trials, or both.
 - Ms. Lerud stated that they are researching what the cause may be. She acknowledged that some cases have been languishing over the last few years but stated that she believes many of them are the result of new filings. She added there is speculation that people are being encouraged to invoke their right to a speedy trial and may not be as likely to enter negotiations.
 - Chief Justice Stiglich stated that they are also seeing an increase in filings but that she is not certain what the driving factor is, or if these numbers will be the new standard.
- VI. Other Items/Discussion
 - Mr. McCormick to provide an overview of the AOC's current projects.
 - Legislative funding was granted to build a training facility in the Carson City Law Library which will increase the AOCs ability to deliver in-person and distance education.
 - The state-wide e-filing system, state-wide jury management system, and self-help portal are still in the works.
 - The Civil Traffic CMS is still being worked on as well as a new CMS option for courts.
 - Additional positions awarded during the Legislative Session will be utilized in the Audit Unit allowing them to update their auditing cycle. Additional positions were also added to the Judicial Education department to address the gap in front-line staff training.
 - Mr. Grierson shared with the members that Tomilynn Clark will be running for Mrs. Nevada in the upcoming Mrs. America pageant. She is a CASA volunteer and will be promoting the program during her campaign.

Committee Meeting of October 13, 2023 December 1, 2023, JCSN Prepared by: Zaide Martinez, CIP Coordinator

- The Annual Community Improvement Council (CIC) Summit was held September 27-29, 2023. CIC teams created their Action Plans for 2024.
- CIP established a statewide subcommittee of dependency judges and masters/magistrates. This subcommittee would function as an ad hoc subcommittee of the CIP Select Committee and would provide significant benefits by allowing enhanced cohesion between CICs and dependency judges.
 - The current focus of the Subcommittee is looking into guardianship and out-of-home placement practices occurring before the formal dependency process.
- CIP granted an extension to five awardees who applied for the 2022-2023 Timely Permanency and Termination of Parental Rights Subgrants. CIP awarded two new awards for the 2023-2024 funding opportunity.
- The Judicial, Court, and Attorney Measures of Performance (JCAMP) Leadership Team has been meeting regularly and has selected 53 of the 71 JCAMP measures. The JCAMP Leadership is working to reduce the measures and discuss sustainability for continuous quality improvement.
- CIP is working closely with the Children's Bureau and Agency partners to prepare for Round 4 of the Child and Family Services Review (CFSR).
- CIP collaborated with the Division of Child and Family Services (DCFS) to provide domestic violence training for CICs. DCFS has been working with Health Management Associates (HMA) to assess Nevada's domestic violence practices and child welfare outcomes. The goal is to share with the courts their findings and information that will help legal stakeholders align their practices with the agencies.
 - Five out of the 11 CICs registered for the training.
- The 2022-2023 Self-Assessment and Strategic Plan was submitted to the Children's Bureau on June 28, 2023. CIP received notice of approval for Nevada's FY 2024 CIP Grant.

- I. Call to Order
 - Justice Cadish called the meeting to order at 2:02 p.m. in the absence of Chair Stiglich.
 - Ms. Harper called roll; a quorum was not present, but the members agreed to continue the meeting as information only.
 - The meeting summary from June 12, 2023, was not approved.
- II. 2023 Legislation Implementation Issues and Corrections
 - Chief Judge Jones asked if the timeline for the COLAS could be accelerated. She felt the judges should be treated like all other state employees and she was not aware of any others that are required to wait for salary increases. This is a delicate political topic.
 - Judge Drakulich commented that the State's Constitution limits the intervals for salary increases, but not COLAS. She wondered if this borders on an equal protection issue. She felt it would be beneficial to meet with the Legislative Counsel Bureau before the next session to find out how they would respond to a change. There is also an equity issue in certain circumstances as city and county-paid judges and other staff are being paid more than district judges.
 - Justice Cadish suggested that bringing this topic back to the Legislature for additional changes may not be practical.
 - Mr. Hillerby agreed with Justice Cadish, that future discussions with Legislators will likely create issues as they were unhappy during initial negotiations.
 - Ms. Barnes added that the risk of returning to this topic in the next session could be much graver than the reward. The Legislative Branch may move backward on what was accomplished during the 2023 Session.
 - Judge Miller suggested a meeting with Chairman Yeager to get his opinion on this subject.

III. Possible 2025 BDRs

- Mr. McCormick asked the members if they felt there was a need to form a workgroup to attempt to correct the procedural issues with <u>AB116</u>.
 - Mr. Clark commented that a BDR for corrections is not a bad idea and that legislators will come after the driver's license suspension issue again. Things could change drastically depending on the outcome of the 2024 elections. He will be working with NJLJ to develop the necessary language.
 - Judge Bishop felt judges need to submit a correction to ensure additional issues are not created.
 - Judge Miller suggested making changes to correct the juvenile jurisdiction question.
- Guardianship
 - Mr. McCormick commented that during the last session, the Committee submitted <u>SB15</u> which included several changes including a fee change which is where the bill got hung up. He would like to submit the changes again without the fee. He offered to get input from the Guardianship Commission.
- Driver's License Suspensions
 - Mr. McCormick commented that legislators have reached out to Chief Judge Higgins expressing concern for this topic. The fees and the process at the DMV become a barrier for people trying to regain their licenses. Child support driver's license suspensions are also an issue that may benefit from small adjustments, however, there is Federal Law on the issue.
 - Judge Miller suggested creating a way to track who has paid fees to get their license back.
- Fines and Fees
 - Mr. McCormick explained that Chief Judge Higgins asked to add this to the list. He attended a conference put on by the National Council of State Legislatures where fines and fees were discussed. This would be a broad discussion to see if the Commission members feel the need to address fines and fees.
 - Judge Bishop commented that the lower courts are still reliant on the fees.
- Small Claims and General Civil Monetary Limits
 - Mr. McCormick commented that currently the civil limit is \$15,000 at the justice court level, and anything over that is sent to district courts. Small claims are \$10,000. He asked the members if there was a need to change these limits. The topic will be tabled for discussion at future meetings.
- Misdemeanors charged in the same case are required to be sent to district courts with bound over gross misdemeanors or felonies.
 - Judge Miller commented that NRS 173.115 requires that if there is a felony or gross misdemeanor, all misdemeanors must be included in the same complaint.
 - Justice Cadish pointed out that they may not be resolved together.
 - Mr. Conway added that in Washoe County, they stay in justice courts which causes problems in trying to close out cases. There is a concern that district court judges may not have jurisdiction over the cases from lower-level courts.
 - Judge Miller added that Clark County binds them up to district court, and the district court resolves the charges along with the felonies and gross misdemeanors.
- Administrative Assessment Reform Bill
 - Mr. McCormick explained this is the only source of discretionary revenue for limited jurisdiction courts.
- IV. Other Potential Bills
 - Chief Judge Jones discussed multiple concerns.
 - The statute for technical and non-technical parole and probation violations could use clarification as to what constitutes a non-technical violation.
 - Honorable and dishonorable discharges need to be clarified. If money is owed, should an honorable discharge be granted? This also applies to record sealing. She disagrees with the calculation of good-time credits.

- The 48-hour bail hearing rule has been more difficult for the rural courts, and they should be canvased to see what can be done to alleviate the difficulties.
 - Mr. Clark commented that a one-time general fund allocation was granted to pay for additional judges or overtime necessary to implement the 48-hour rule. He would like to see this one-time allocation become long-term funding. Townships within larger counties can also benefit from the additional funding.
 - Judge Bishop added that he is in favor of 48-hour hearings with the additional funding.
- Ms. Lerud commented that post-sentence, no-contact orders do not go anywhere concerning the state repository. If there is a post-sentence, no-contact order entered in a domestic battery case, the order is good, but law enforcement has no way to access it. They do not immediately arrest, leaving victims at risk.
 - Mr. McCormick offered to reach out to the District Attorney's Association for input.
 - Judge Bishop added that immediate arrest may not be permissible, and that specific statutory coverage should be considered.
- Mr. Grierson requested a bill be reserved for the 8th Judicial District for additional judges.
- Mr. McCormick added that the <u>SB418</u> questionnaire for anyone newly running for judicial office has been built and is available through the <u>Secretary of State website</u>, and has been disseminated to all county election officials. He said that we are still working on the lay justice of the peace test required by <u>SB354</u>.

- Ms. Gradick informed attendees that the Nevada Supreme Court Law Library has contracted with LexisNexis to offer Lexis+ access to Nevada's courts. If interested, please let Ms. Gradick know.
- Ms. Gradick informed attendees of 2024 Judicial Education event dates; additional information will be made available closer to event dates.
- Ms. Gradick informed attendees that, with the approval of the Court's budget requests during Legislative Session, the AOC anticipates the addition of several new positions over the next several months.
 - Additional positions are being added to the Audit team, the Court Services Unit, Judicial Education, and others.
 - Attendees briefly discussed how this increase in staff could benefit court programs such as CIP and the Court Interpreter program.
- Civil Infraction Citations
 - Attendees discussed juvenile civil traffic. The bill places jurisdiction with "justice court" instead of "juvenile" court. Different courts have been interpreting/applying the language differently.
 - Judge Soderquist informed attendees that Elko made the juvenile master a pro tem in the justice court as a "work-around" for this issue.
 - Attendees discussed the use of senior judges and judge pro tems; there's a need to clarify and document roles for each case/citation.
 - Attendees discussed how to handle hearings when associated criminal allegations are denied. Some courts set the evidentiary hearing for a later date and send notice to the parties; the judge can consider whatever evidence is presented depending upon who shows up for the hearing.
 - Discussion was held regarding the role of the law enforcement officer; nothing in NV law allows the LEO to "stand in" for the prosecutor at the hearing.
 - Attendees discussed whether language in AB116 allows for "informal hearings".
- Bail Schedules
 - Judge Soderquist informed attendees that the NJLJ voted to appoint a workgroup to develop a uniform bail schedule but not all limited jurisdiction judges are members of the NJLJ association so an "approved" schedule wouldn't be completely "uniform" for all courts.
 - Judge Soderquist referenced the "rural" bail schedule proposed by Nevada State Police and asked attendees for input regarding developing and adopting a uniform bail schedule in the North Central Region.
 - Some courts are still using the schedule the group developed in 2013; Elko courts never officially adopted this schedule.
 - Elko County is, currently, using its own schedule that sets amounts by category instead of individually; it's based on the recommended schedule developed by the Bail Schedule Subcommittee of the Committee to Study Best Practices for Evidence-Based Pretrial Release.

- Attendees agreed to hold a bail schedule workshop following the next North Central Regional Judicial Council meeting on November 17, 2023.
- Cloud Gavel Input Request
 - Judge Fortune asked attendees for input regarding Cloud Gavel.
 - Some judges have used it but expressed concerns regarding the use of "declaration" instead of "affidavit" in the templates; this causes confusion on law enforcement testimony.
 - Discussion was held regarding what authority would allow a warrant based on an unsworn declaration.
- Community Service Reports
 - Senior Judge Feasel participated in a community treasure hunt for the Carlin Historical Society.
 - Judge Calton hosted the local high school's forensic science class at Well's courthouse.
 - Judge Montero participated in a community Veterans' breakfast and hosted elementary students at his ranch for "Farm Day."
- Other Items and Discussion
 - Ms. Gradick provided attendees with a brief overview of the water law judges' pilot program, training, and appointment processes as approved in the recent ADKT 0576 Order.
 - Judge Montero issued a blanket approval for senior judges within the region to attend these meetings without having to seek approval (via the JCSN Bylaws) each time.
- Informational Documents
 - Attendees reviewed the judicial security resources documents; a comment was made that people seem to be increasingly angry when they come to court.

- AOC Updates

 - Ms. Gradick provided attendees with a copy of the e-filing flyer that was sent out from the AOC and the "POP Onboarding" announcement that was sent out on behalf of DPS (*please see materials for these handouts*).

 - Ms. Gradick confirmed that the AOC IT team is working to address concerns with GJS but there is also an effort being made to move this back to Court View.

 - Judge Vecchiarelli participated in a mock trial with local elementary students.
 - Judge Young presented to graduates of the Jobs 4 Nevada Graduates program.
- Other/Discussion

 - Chief Judge Simons called the meeting to order at Noon.
- II. Call of Roll and Determination of Quorum Status
 - Ms. Harper called roll; a quorum was not present, however, the Chair elected to proceed with the meeting as information only.
- III. Approval of Meeting Summary
 - There being no quorum, the summary was not approved.
- IV. AOC Updates

- Specialty Courts
 - The theme for the Nevada Specialty Court Conference will be Silver State, Gold Standard, and will be held on October 16–18, 2024 in Reno.
 - The Committee will fund 10 slots for attendance at the national conference, All Rise, in May of 2024, being held in San Diego, CA.
 - 2025 funding applications have been distributed.

- The Committee will be holding elections for terms expiring on 12/31/23.
 - Chief Judge Simons requested the list of members and terms be routed to the Washoe Regional members for reference.
- Judicial Education Upcoming Events
 - In your materials, you will find details regarding the Limited Jurisdiction Judges Seminar coming up in January.
 - The annual AOC Family Law Conference will be held on April 9, 2023, followed by the 2024 District Court Judges Seminar on April 10th-12th, at the Aliante Resort and Casino in North Las Vegas.
- IT Projects Update
 - The AOC recently sent out a letter and flyer with updates on the many IT projects underway. Please see the materials for more information.
 - Update as of 10/24/23: There are six courts currently utilizing CourtView for Civil Traffic with more being added.
- V. Discussion and Action Items
 - Mental Health Summit
 - Judge Walker commented there will be a Washoe County Mental Health Meeting on January 12 or 13, 2024. There are 150 slots for stakeholders, police, judicial, medical, county, and city leaders to tackle the mental health issue using the Sequential Intercept Model.
 - The Limited Jurisdiction Winter Seminar is scheduled for the same week in January.
 - Judge Walker requested that courts send their Court Administrator if the Judge cannot attend the Mental Health Summit.
 - The Board of County Commissioners has agreed to partner with the Judges, County, and Cities to address mental health and elder issues. The meeting invitation will be sent out next week.
 - Mental Competency
 - Judge Walker commented that in January 2023, the wait list to get into Lakes Crossing was about 35 persons and the wait time was four to six months. As of last week, the wait list was less than seven people and the wait time was one-two months. He feels the wait time can still be improved. The new process is showing remarkable success.
 - The Sheriff will be signing a contract to begin jail-based restoration to competency services to educate people about the criminal and court process including the roles of all players involved.
 - Currently, there are 57 persons accused of gross misdemeanors or felonies on the competency docket. Last month there were 11 admissions to the list, of those, 7 cases were closed. The real success so far is the inertia as no one has impeded the new changes.
 - Judge Walker is ready to begin accepting misdemeanors. There is a need to create a record of how and why the competency issue was raised and how the case got to the District Court. He created and routed forms to Washoe judges to address these needs, but the forms remain unfinished.
 - Mr. Conway addressed two issues with the forms. He was not aware the forms were to be used on the record, in court. He plans to address the forms at the next judges' meeting, which will be held later in the month. The second issue is the District Attorney's position on whether or not a hearing is necessary when the forms are received.
 - Chief Judge Jones requested that Judge Walker keep track of areas that may need legislative change.
 - Court Updates
 - Second Judicial District Court
 - Chief Judge Jones commented that she has recently changed her name.

- The District Court may be receiving a new building through the Washoe County Strategic Plan.
- The court staff will be reestablishing their Evidence Committee after hiring a new Evidence Clerk.
- There have been four to five cases on each grand jury docket. Cases are being bound over and accompanying inditements. The number of trials has nearly doubled since the last 10-year high mark and may triple based on the current numbers.
 - Judge Breslow added that he has also seen a vast increase in trials this year based on previous years.
- A new case management system, with Journal Technologies, is currently under contract.
- Reno Justice Court
 - Judge Bertschy commented that three new staff members have been hired.
 - Specialty Courts Program Coordinator
 - A second Assistant Court Administrator
 - An additional Deputy Clerk
 - They will ensure one of the members of the staff will be attending the Mental Health Summit.
 - Judge Breslow asked if the 10% cash option on bail for Category A and B charges has stopped.
 - Chief Judge Higgins commented that his court never offered this option. They only offer 10% on a case-by-case basis, on Category D or E charges.
 - Judge Bertschy commented that an administrative order was entered several months prior indicating that the option is no longer available.
 - Chief Judge Jones added that she agrees with Judge Breslow and does not allow the option for her cases.
- Reno Municipal Court
 - Chief Judge Haslet-Stephens commented that the court was awarded two grants from the Bureau of Justice Assistance.
 - A four-year, million-dollar grant for the Community Court to expand and enhance services, including a new case management program and temporary housing for a subset of their participants.
 - A million-dollar umbrella grant was awarded for their specialty courts to enhance treatment and testing.
 - They will be hosting a convening of Regional Community Courts on February 8, 2023. Several community courts have been invited to visit their town and attend a conference to discuss best practices.
- Sparks Justice Court
 - Chief Judge Higgins commented that their Court Administrators are working on the forms for Mental Competency.
 - He has been drafted to sit on a Legislative Committee in preparation for the next Session. He attended a conference for the National Center for State Courts to discuss fines and fees. He believes all administrative assessment fees will be eliminated. He pointed out that the majority of the AA fees can easily be subsumed into the State General Fund with the exception of the \$10 court facility fee and the \$7 portion from the main AA fee that goes to the court.
 - In California, there is a Court Retirement fee that pays for Judicial Retirement.
 - He would love to get signed up for the new E-filing system the Supreme Court is offering for free, he is not a fan of the program they currently use, E-file.
- Sparks Municipal Court
 - Judge Spoo commented that the Sparks Attorney's Office has been working with the police department on domestic violence-related matters. One of the initiatives they have created is the Domestic Abuse Response Team (DART) which offers intensified training

for specialized units within the Sparks police department to respond to domestic violence matters.

- Incline Village Justice Court
 - Chief Judge Higgins commented that Judge Tiras moved into a new facility at the library in Incline Village.
- VI. Adjournment
 - There being no further discussion, the meeting was adjourned at 12:47 p.m.
