

In high school, college, and law school, it was necessary for me to work a great deal. Often, I held full-time employment while attending school full-time. As such, there were fewer opportunities for me to participate in as many clubs and activities as I would have liked.

Activities in high school

- a. Tennis: I played tennis every year of high school.
- b. <u>Debate</u>: I was extremely active in our school's debate and speech program. I participated in both the cross-examination and Lincoln-Douglas style debate formats. I also frequently competed in the impromptu speaking format. I qualified to compete at the state level tournament in both debate and impromptu speaking formats my Junior and Senior year of high school. Though I qualified for the state tournament my Senior year in both debate and impromptu speaking, I did not compete as I stopped attending high school before the tournament was held that year.
- c. <u>Peer-Helpers:</u> This organization was designed for high school students to partner with elementary schools in order to educate and motivate elementary children. On a monthly basis, we would present engaging, informative talks to children in hopes of helping them avoid drug use and other negative outcomes. I served as president of this organization my junior and senior year of high school.

- a. <u>Debate:</u> I competed in CEDA-style debate while at the University of Utah. My partner and I placed at several national debate tournaments. My partner and I were awarded the University of Utah "Team of the Year" award in 1994.

 - a. Yes, I was employed during my second and third year of law school.
 - b. I worked between 20 and 30 hours per week, on average.
 - c. I was employed as a Resident Director of Student Housing. I oversaw a staff of three resident directors and residential housing facility of 100+ students. I developed educational and social programming for the facility, enforced housing policies and practices, and acted a liaison between the students and the University.
 - d. My employer was Case Western Reserve University Housing.
 - e. This employment started in August of 2001 and ended upon my graduation from law school in June 2003.

<u>Civil Litigation Clinic</u>: During my third year of law school, I had the opportunity to represent plaintiffs and defendant in civil litigation matters. I was responsible for all aspects of a client's civil case. This included client interviews, case assessment, drafting of pleadings and motions, conducting discovery, and engaging in settlement negotiations. I was especially proud of the fact that our clinic represented the most underserved, and poorest, populations in the Cleveland area.

As a civil litigator and later, as a public defender, I spent most of my working time in court or preparing for court. I would estimate that 85% of my time as lawyer prior to becoming a Court Master consisted of litigation matters.

In the 5 years prior to my being selected as a Court Master, none of my litigation cases involved jury trials. If the parties were not able to settle, and a trial was necessary, these matters were set for bench/evidentiary trials.

18. Give the approximate number of jury cases tried to a conclusion during the past five years with you as lead counsel. Give the approximate number of non-jury cases tried to a decision in the same period.

In family law, it is rare that cases are tried. The vast majority of cases settle prior to being tried in front of a judge. During my time as public defender representing parents who had children removed from their care, we would often conduct evidentiary hearings on matters related to the removal and return of children. I would estimate that I participated in more than 50 of these types of hearings.

- c. This case illustrated the difficulty of unsettled law and the tactic of finding a friendly forum for a particular view on the law.

 - b. The parties were unrepresented. I served as Court Master.
 - c. This case demonstrated how difficult it is when a family is presented with too many "doors" to the family court and too many differing views, and rulings from the bench.

 - c. This case was difficult as even under applicable law, there was no "good" result, but only a choice between bad ones. Also, the amount of time the parties waited to pursue their claims materially affected their claims.

If selected for this position, It is highly likely that the appointed judge would face an almost immediate campaign to retain the seat. The person chosen will also have to learn the position of District Judge at the same time as they were defending their seat.

I am uniquely qualified for this dual challenge for two reasons:

1. I served as Court Master in the Family Court for over seven years and as a law clerk there for an additional two years. I have a realistic knowledge of the workload and the actual case flow "behind the bench",

AND

2. I have prepared for a campaign for family court judge regardless if I am appointed by this commission or not. My family sold our home over a year ago to finance a campaign, I have spent a great deal of money marketing my name to the general public through my law firm, and my partner and I have specific provisions regarding my run and election to the family court bench.

Preparation is certainly no guarantee of a positive outcome, but I believe that I am uniquely qualified to handle the difficulty an appointment to this seat would cause most applicants.

"Remember this pain, it will be useful to you." - Ovid

I was the child that was taken into foster care. I was the child of a mother who battled alcoholism and pill addiction most of her adult life. I was the child who was left in the care of his grandmother until he was almost five because his single mother could not shoulder the responsibility of caring for a precocious, high-spirited child like me.

I was the child whose primary caregiver and grandmother died too soon and was placed back into the care of my mother. I was the child that was put into short-term foster care more times than he can remember. As a child, I never really understood why any of it was happening but had some notion it was related to my mother. I do remember that one of the times I got to leave with the nice lady from social services, someone mentioned that my mother's boyfriend had brought a gun and was threatening my mother and myself. I vaguely remember the man. He wasn't the first man who had hurt and abused my mom in front of me. I remember trying to make "traps" out of coat hangers and Legos to keep bad men away from my mom. I never shared that particular memory with her.

I also remember long bus-rides. We spent hours on a bus when I was a kid. I also remember being left alone for hours in a small trailer while my mother waited tables at a job that would not allow her to bring a small, rowdy boy. Ironically, though my mother waited in tables in busy restaurants I was hungry most of the time.

I'm also the child who later found a good man to be his stepfather and an inherited a stepfamily that understood how to take care of a child. As good as they were, a lot of the of painful lessons from my early years remain, even to this day. As a family law attorney, and during my tenure as a Family Court Master, I used that pain every day. Those experiences give me insight

into many of the people that came into family court every day. It made me empathetic. It helps me understand many people in a way that most of my colleagues in the legal profession cannot.

I do not begrudge anyone for having more opportunities than I have had. I hope that I will continue to provide that kind of certainty to my own sons. I want them to never want for food, clothing or shelter. They should have opportunities to volunteer, study abroad, and take unpaid internships that turn into career opportunities down the road.

I don't want to suggest that I be appointed as a judge because I had a rough childhood. Many people have dealt with much worse than I have. What sets me apart, I believe, is what I have done with those experiences and trauma. I used that pain every day as a Family Court Master to understand, relate, and make a connection with many of the litigants who found themselves in family court. I believe it is precisely those experiences, that pain, that allows me to be the caliber of judge required for family court.
