Music. Throughout high school I was very involved in music, playing the cello in the school orchestra, all-state orchestra, and the Sunset Symphony, Las Vegas's youth orchestra at that time. With the Sunset Symphony, I traveled to New York City and performed with other youth orchestras from around the country at Carnegie Hall. I also participated in numerous piano performances and recitals, including accompanying many fellow student musicians at music festivals and competitions; performing a senior recital at a local music studio; and playing at my high school graduation. I also began playing the organ at my church as a volunteer during this period of my life, something that I still do today.

American Academy of Achievement. In 1991, I was selected by my high school to attend the Academy of Achievement's Golden Plate Awards in New York City. The program was designed to inspire young student leaders by having them meet with luminaries in a wide array of occupations from across the United States. During this program I was able to meet with and hear from such people as Reuben and Rose Mattus, founders of Haagen Dazs, Clyde Tombaugh, astronomer and discoverer of Pluto, Ralph Lauren, the fashion designer, and even Oprah Winfrey. It was an incredible, unforgettable experience and just as inspiring as intended.

Honor societies. During high school I was also very active in honor society and key club, including participation in many volunteer activities around Las Vegas. In addition, I graduated as one of the valedictorians of my high school class and spoke at the graduation ceremony.

College

Teaching assistant. In college I spent much of my time in the political science department, the highlight of which was as a teaching assistant for Professor Stanley Taylor. Professor Taylor taught the political science research and writing course, and in that course, well before the advent of the internet, he taught us to rigorously test our sources and hold ourselves to the highest of standards in writing and research. As teaching assistants, we were trained to teach these same high standards to the students and to hold them accountable for their work product. I emerged from this class and my teaching experience prepared to undertake serious research, to critically analyze information I encountered, and to critique and edit my own and others' writing. It is no exaggeration to say that I have used the information learned from attending and teaching this class every day of my life.

Study abroad. I was fortunate to attend college debt free through a combination of the BYU Trustees Scholarship, the Golden Nugget Scholarship (sponsored by the Wynn family), and the Nevada Lion's Club Student Speaker Scholarship. During my sophomore year I was able to use this scholarship money to participate in BYU's study abroad program in Vienna, Austria, including two months of travel on the Eurail train system throughout eastern and western Europe. That year, 1992, was a unique time to visit many countries in Europe, as the dissolution

of the USSR had just taken place, and the Berlin wall had fallen shortly prior. The differences between east and west were quite stark. Visits to East Germany, Poland, Slovakia, the Czech Republic, Hungary, and Slovenia impressed upon me the importance of functional government and the rule of law.

Senate internship. During the summer of my sophomore year, I worked as an intern in the office of Senator Harry Reid, which further impressed upon me how fundamental functional government and the rule of law are to the health and prosperity of a society. Senator Reid had a relatively small office at that time and took a personal interest in his interns. I remember the care he took in giving me research projects and assignments and discussing them with me. Through him and his staff I was exposed to a wide spectrum of issues and events relating to government and the rule of law, and had a first-row seat to observe the importance of personal relationships, reputation, and integrity that Senator Reid exemplified so well. Thrillingly, I was able to attend the confirmation hearing of Ruth Bader Ginsburg and take a morning jog with President Bill Clinton in a show of youth support for his budget bill that year.

Other activities and honors. I majored in international relations, with an emphasis on Germanic culture and language and a minor in economics. I was active in the Pi Sigma Alpha political science honor society, serving as its special events coordinator and co-directing a University Symposium on Race, Gender, and Religion during my senior year. I also served as an editor of BYU's Journal of International and Area Studies. I graduated *summa cum laude* and with a University Honors diploma.

I was employed full-time as a law clerk during the summers in law school.

In 1997, I worked for half of the summer (June-July) at the office of Dr. Markus Wanger Advokaturburo, in Vaduz, Liechtenstein. I conducted research into the similarities and differences between legal entities such as trusts in the United States and Liechtenstein legal systems. I also translated various legal documents and communications from German to English in order to assist the firm in communicating with English-speaking clients.

The second half of the summer of 1997 (July-August), I was employed full-time as an extern in the office of the Honorable Lloyd D. George. I observed and assisted with preparation for court hearings and proceedings, researched cases, and drafted memoranda and orders for review by the judge and his career law clerk Troy Healey. I considered Judge George and Troy invaluable friends and mentors during my early legal career in Las Vegas.

During the summer of 1998, I was employed full-time as a law clerk at Milbank Tweed in New York City. I rotated through the departments of litigation, project finance, trusts and estates, and banking, completing various projects and research under the supervision of the firm's attorneys. I spent one month of that summer in Milbank's Singapore office, reviewing credit and loan documents and drafting letters to foreign counsel outlining the potential legal issues and problems they presented.

The Harvard Legal Aid Bureau. One of my most meaningful activities during law school was my membership, for two years, as a practicing student attorney at the Harvard Legal Aid Bureau. As a member of the Bureau, I represented clients from around the Boston area in Social Security Disability Insurance claims and family law matters. Representing my clients pushed me well out of my comfort zone, teaching me to be assertive and quick on my feet, and also teaching me what it means to work tirelessly on behalf of a client. I will never forget being yelled at by opposing counsel and managing to maintain my cool; waiting nervously for my first case to be called in a packed family law courtroom; filing last-minute evidence with the SSA administrative law judge during Christmas vacation; and sitting with my practicing attorney supervisor at lunch after a big win discussing the context of that win in light of the many services still needed by our client in addition to the legal services we provided.

Research assistant. In my final year of law school I served as a research assistant to Professor Anne Marie Slaughter as she began research for her book on the rise of international law, *A New World Order*. I was also enrolled in her class on international law and completed my thesis with her as my advisor that year. While her knowledge of and perspectives on international law were deep and fascinating, it is her role as a working mother that I remember most distinctly now. She spoke openly of family obligations with us as we worked together, and shared with us her strategies, her struggles, and her solutions to parenting while simultaneously building a career as a legal academic. I admired her dedication to both her family and the law so much and still do.

Other activities. I served as Co-Chairperson of Harvard's Battered Women's Advocacy Project, spending many hours in local courtrooms assisting women seeking TROs for domestic violence problems. I was an articles editor for the *Harvard International Law Journal*, and I was active in the European Law Society, which facilitated discussion and interaction between JD students and LLM students from European countries.

Importance of the case to you and the case's impact on you:

This case exemplifies two things to me: (1) the crucial lawyerly skill of managing the interests, opinions and legal arguments of multiple parties and choosing which arguments among many to focus on during the few minutes of argument time; and (2) the necessary appellate skill of learning a new body of law with every case yet focusing with precision on those issues most likely to have an impact on appeal. The first skill is particularly important to attorneys representing the State in cases of statewide import like this one. I have seen this dynamic play out many times in the various multistate actions Nevada is involved in around the country, but this case was the first case of this type for which I was personally and solely responsible. I have been developing the second skill for practically my entire legal career, but this case stands out as one that presented a particularly challenging and important area of law and required deep cooperation between the Office of Solicitor General, the AG's Division of Government and Natural Resources (GNR), and the office's clients. I remain in awe of the attorneys who assisted me in preparing to argue this case. They were patient with me, deeply knowledgeable in this area of law, and absolutely dedicated to do right for Nevada.

Your role in the case:

I argued this case in the Nevada Supreme Court after briefing by the GNR attorneys in our office. In order to do so, I spent weeks working closely with attorneys from the State

Engineer's office, the Division of Wildlife, and GNR. This case required examining Nevada history and practice, as well as law and policy, in one of Nevadas' most important areas of law—that governing water in the State. It also necessitated careful consideration of which arguments were most important for the State (as opposed to private parties) to make at oral argument. This case required close contact and extensive discussions with our clients, which I spearheaded as I prepared for the argument.

Importance of the case to you and the case's impact on you:

This case, occurring early in my career, provided me with the type of experience many attorneys dream of. I was primarily responsible for drafting a Petition for Writ of Certiorari to the United States Supreme Court after an adverse decision for our client in the Ninth Circuit. All of the nuts and bolts of that process fell to me as the most junior attorney, from arranging the printing of the petition, studying and knowing by heart the Supreme Court's rules, and circulating and revising multiple drafts of the petition. When the unimaginable occurred—cert was granted—I was able to observe and learn from true experts in Supreme Court practice. And I was able to be present in the Supreme Court when the case was argued by Maureen Mahoney on behalf of our client. This experience has come in handy during my time as Solicitor General, where we engage in regular amicus and petition briefing in the Supreme Court.

Importance of the case to you and the case's impact on you:

This was one of the first big appeals I worked on in Nevada as a practicing attorney. I always think of this case as my introduction to the practice of appellate law in Nevada. To Dan Polsenberg's credit, he entrusted me with producing the entire first draft of our opening brief, which required review and analysis of an extensive trial court record, including transcripts from the jury trial. He then taught me, through multiple successive drafts, how to winnow down the issues for appeal and how to structure the brief in a way that would catch and keep the court's attention. I also had substantial client contact throughout, as the issue on appeal—liability of a surety—was extremely important to our client and its industry. This case remains the most cited of my cases according to Westlaw. In addition, this case prepared me for handling the aftermath of an appeal—the proceedings on remand. We were ultimately successful in obtaining an award of attorneys fees on behalf of our client, further cementing our good relationship with them.

Your role in the case:

I worked as an associate attorney with Dan Polsenberg on all aspects of this case, from the time it arrived in the office until ultimate disposition of the case on remand to the district court. I researched, reviewed court records, drafted briefs and motions, consulted with the client, assisted Dan in argument preparation, attended court hearings, and was generally responsible for detailed knowledge of the case and the issues it presented.

One of the benefits of practicing appellate law is the opportunity to be part of the establishment of the rule of law—legal precedent that creates the framework within which lawyers and judges operate. To me, this is one of the highest callings of the law, to examine broadly how and why our legal system operates the way it does, to think critically about what the law should be and how far it should extend or how much it should be restricted. In particular, working on a case that results in a published, precedential decision is a privilege and a responsibility.
