ORDER


On January 4, 2008 this court entered an Order adopting the unanimous recommendations of the Indigent Defense Commission including, but not limited to, the adoption of performance standards. Subsequently, on March 21, 2008, this court entered an order that referred the performance standards back to the Indigent Defense Commission for review and revision, if necessary and ordered the Indigent Defense Commission to provide a report and any revision to the performance standards to this court in writing on or before June 30, 2008. This court also temporarily stayed the implementation date for the performance standards until July 15, 2008.


The written report including the proposed revisions was timely filed, and on July 1, 2008, Federal Public Defender Franny Forsman and Clark County Deputy District Attorney Nancy Becker appeared at this court's hearing on the matter. This court has determined that the Rural Issues Subcommittee should have the opportunity to review the proposed revisions to the performance standards. Accordingly,




IT IS FURTHER ORDERED that the temporary stay for the implementation of the performance standards is extended to September 5, 2008.






